1. Acceptance of Terms

5. No Legal or Medical Advice

6. Free Pilot Program

The Free 28-Day Pilot:

- Includes **one (1) participant only**
- Is provided for evaluation purposes
- May be modified or discontinued at EABS's discretion

Additional participants require a paid subscription.

7. Billing & Payment Terms

Initial Payment

- Required before onboarding any paid participants

Monthly Billing

- Billed on the last calendar day of each month
- Prorated for partial months

8. Cancellation

Either party may terminate services with **14 days written notice**.
